

President's Message

A CALL TO ACTION

There is a threat to our sovereignty as a country—when we lose our sovereignty we have lost our country. From May 27 to June 1 the World Health Organization will meet for the 77th World Health Assembly in Geneva, Switzerland. At this meeting they will vote on the Pandemic Accord (Treaty) and the International Health Regulations.

Kristen A. Ullman, president, Eagle Forum is working with the Sovereignty Coalition to get the word out about the stealthy takeover of our nation through WHO treaties. According to Ullman, these two instruments will give the WHO Director-General the sole ability to declare public health emergencies of international concern and to mandate for every nation the global response such as lockdowns, travel restrictions, mandatory testing, vaccinations, and border closures. We will finally lose the freedoms the Biden Administration attempted to take away from us during Covid.

These rights will be snatched from right under our eyes because no one is paying attention. For the US to sign onto any such treaty would be another step in eliminating our sovereignty. The open border is a primary example. According to Ullman, Joe Biden plans to sign onto these treaties without the advice and consent of the Senate. (Art.II, Sec.II) By claiming that the internationally negotiated accords are considered executive agreements, he can do so with an Executive Order.

This is an URGENT CALL TO ACTION to call Senators Catherine Cortez Masto at 202-224-3121 and Jacky Rosen at 202-224-6244. Tell them they must reassert their constitutional authority to prevent the signing of the Pandemic Accord (Treaty) and the International Health Regulations that will sacrifice our national sovereignty and our freedoms.

This must be done by May 27, 2024.

In Defense of Donald Trump

NFRW Spring 2024 Board Meeting & Legislative Day

he National Federation Republican Women Board Meeting was held on March 14-16, 2024. March 14 was designated Legislative Day. After a short bus ride from our hotel, we arrived at the



to the Republican National Committee headquarters in the Eisenhower Building for a brief reception. (See Regent's Report).

The following two days were very intense

Capitol. It was a short walk to the Senate Visitor Center, where we received badges and were cleared through security.

Once inside, we enjoyed a Continental breakfast followed by a presentation on lobbying, both of which were provided by the Leadership Institute. It was during this timeframe that Senators popped in to greet us, thank us for the work we do for the Republican cause, and encouraged us to keep the faith.

Senator Tim Scott was to be our first speaker, but was unable to make it as he was called back to South Carolina. In his place, he sent his entire staff in carrying dozens of long-stemmed red roses, one for each of us. The spokesperson assured us that Senator Scott valued the Republican women's clubs across the nation. Other speakers included Senator Ted Budd (TX), Senator Cynthia Lummis (WY), and Senator Cindy Hyde-Smith (MS).

After taking a group photo, we moved from the Visitor Center to a Senate caucus room in the Russell Building via the Capitol subway. Here, we enjoyed box lunches while listening to our keynote speaker, Senator Katie Britt (AL).

The rest of the afternoon was spent in the senate building, where our task was to visit our senators and lobby them on the need to fix our border, the issue of parental rights, and the economy. The offices of Nevada's two senators were a healthy walk to the Hart Senate building. I chose to spend my limited time in the Russell building, where I visited the offices of Senators Capito (WV), Josh Hawley (MO), and Cynthia Lummis (WY).

At the conclusion of Legislative Day activities, those of us who were Regents walked from the Capitol with meetings. Friday was the presidents meeting focusing on the Empowering 70K membership drive and the March Madness competition. It was here that we heard about the disrupters attempting to tear apart successful clubs and state federations for various reasons. We learned about the strike forces planned for battleground states. Nevada being one, I am waiting to hear more about that.

The Achievement and Campaign awards were addressed—look for 2024 forms around June and continue to use 2023 as a template, as no major changes are expected. I stopped in to listen to a standing committee meeting on Homeland Security that was of interest to me.

After lunch on Friday, the Board of Directors Meeting went into recess about 5 p.m. It was called out of recess Saturday morning and concluded on schedule on Saturday afternoon.

Our Region 2 meeting was held on Friday. We combined our meeting with dinner. It was nice to finally meet the Zoom voices in person. The discussion focused on club membership and the Region 2 meeting being planned for January 2025 at the Reagan Library. This was a pleasant way to get to know the ladies we will be working with.

I was impressed with how efficiently and organized the meetings were run. They gave me positive insight into the inner workings of the national organization and the importance of all eyes on the same prize: achieving our goal of regaining Republican control of our government under the leadership of America First, Donald J. Trump.

TIPS ON PERSUASIVE SPEAKING

Missy Day's tips on persuasive speaking were referenced in the Report on the Leadership Conferences. She distributed them at the Southern Leadership Conference.

- 1. Know your audience: Understand your audience's demographics, interests, and concerns so you can tailor your message to resonate with them.
- 2. Start with a strong opening: To grab your audience's attention from the start, begin with a compelling story, a shocking statistic, a thought-provoking question, or a powerful quote.
- 3. Clearly state your position: Be clear and concise about your main argument or position. Your audience should understand your stance from the beginning.
- 4. Provide evidence: Use facts, statistics, expert opinions, and real-life examples to support your argument. This will add credibility to your speech and help persuade your audience.
- Address counterarguments: Acknowledge
 potential objections or counterarguments and
 provide reasons why your position is stronger.
 Anticipating and addressing opposing viewpoints
 shows that you've considered multiple
 perspectives.
- 6. Use persuasive language: Employ rhetorical devices such as repetition, parallelism, and emotional language to make your speech more compelling and memorable.
- 7. Maintain a confident posture: Stand tall, make eye contact, and use open body language to convey confidence and authority.
- 8. Engage the audience: Encourage audience participation through rhetorical questions, interactive activities, or by using relatable anecdotes.
- 9. Appeal to emotions: Use storytelling and vivid language to evoke emotions that support your argument. People are often swayed by emotions, so connecting with them on an emotional level can be very persuasive.
- 10. End with a strong conclusion: Summarize your main points, restate your position, and leave the audience with a memorable closing statement that reinforces your message.

The Douglas County Republican Women (DCRW), hosted a "Disaster Preparedness Event" on April 20, 2024, at Valley Christian Fellowship. Over 100 county residents showed up to learn how to prepare for emergencies.

The Douglas County Sheriff's Office (DCSO) Explorer Post 2105 Honor Guard's presented the Colors. Two DCSO K-9 handlers brought in their K-9s, Bubba, a male black and tan German Shepard Cross, and Lagatha, a yellow female Labrador

Retriever. The crowd went wild over the well-trained. beautiful K-9s. The first of the three keynote speakers, Sheriff Coverley, a native-born Nevadan, spoke about Douglas County having plans for the



inevitable natural disasters, such as fires and floods. He assured the audience that he and his deputies were always on call to our community. If you call the DCSO, you will have a deputy at your door or the accident scene ready to assist.

Douglas County's Emergency Manager, Kara Easton, is also a native Nevadan. She spent most of her life in Las Vegas, where she graduated with her Executive Master's in Crisis and Emergency Management. Kara came to Douglas County and hit the ground running in her current position in 2023, right after the Atmospheric River incident. She is

the go-to person who oversees the emergency management program, the emergency communication center, and the telecommunications and radio division.

The final speaker, Jim Williams, has worked to organize and coordinate neighborhoods against the threat of emergencies and disasters since 2011. He has been recognized by fire districts and law enforcement offices for his efforts. He founded a Neighborhood Watch program, which now has more than a thousand volunteer participants. He is also a key to Train the Trainer in Neighborhood Emergency Preparedness.

The DCRW extends its heartfelt gratitude to the businesses that played a pivotal role in the success of the event. How Ranked Choice Voting Works

Say NO to Statewide ranked choice voting ... Or your vote may not count!

- 1. Voters rank the top five candidates according to their preference rather than just the one they think will do the best.
- 2. If no candidate gets a majority of votes, the candidate with the fewest votes is eliminated, and the votes that were cast for that person are distributed to the remaining candidates.
- 3. If this new rank results in a majority, the election is over, and a victor is declared.
- 4. If a majority still needs to be achieved after the first round of redistribution, the process repeats itself by eliminating the next bottom-vote getter as needed until someone receives a majority. If you make a mistake, such as giving the same rank to two candidates, the initiative calls your ballot "inactive" or an "overvote," and it may be tossed out altogether.

It's so confusing. Just Vote NO on RCV!

[I need to add that if you do not rank all candidates, the ballot is considered exhausted (inactive) and thrown out.]

Can't reach them by phone?

Many of us use this technique to talk with a Congressman or Senator. I watch for their endorsement of a candidate and make sure I RSVP to any event where they will be present. These events are usually free as they are generally not fundraisers. This way, I can say a few words to them. It is beneficial if you introduce yourself as a donor to him and show him your record.

Leadership Conferences 2024

he NvFRW Regents sponsored the
Nevada Federation of Republican Women
Leadership Conferences. Two Leadership
Conferences are held each year as per our bylaws.
One was held in late January in Minden, Nevada, and the other in early February in Las Vegas. The meetings are structured around the same agenda. We focused on the National Federation and what it provides to our club members. We addressed the
NvFRW and what it gives to our club members.

We held a breakout session to allow attendees to learn about the positions they hold in their clubs. Finally, we had a skill-building session on how to use persuasive speaking tactics when speaking to non-Republicans or those suffering from TDS (Trump Derangement Syndrome).

Mendy Elliot, a lobbyist, political strategist, and member of Mt. Rose RW, spoke to those attending the Northern Conference. She spoke of the importance of gaining the Independent's vote and distributed data on why they are important.

Missy Day, an Executive Coach, Public Speaker, and President of RWLV, provided the Southern Conference with information on finding common ground with someone with strong opposing opinions. Both speakers reinforced that it is possible to find a starting point for a conversation based on events in everyday life and universal emotions.

NvFRW Spring Board and General Membership Meeting

Our Spring Meeting was held in Las Vegas at the Suncoast Hotel and Casino the weekend of April 12 and 13. The Executive Committee meeting was held on Friday, followed by the Regent's meeting and reception.

Saturday morning started with the President's Roundtable. The presidents shared successful events, upcoming events, and tips on growing their clubs. The meeting was called to order at 9 a.m. After establishing a quorum, the Executive Committee and Presidents approved the Standing Committee Chairs. Executive

Committee reports and Standing Committee reports were given. Our Parliamentarian Erica Zajac kept us on task following the Parliamentarian Procedure.

The 2022 Audit Report was presented, and Four Resolutions were passed. Three resolutions passed unanimously. The Resolutions In Support of Voter ID, Opposing Ranked Choice Voting, and Opposing Open Primaries passed unanimously as presented. The Lands Bill, Opposing Transfer of State-Controlled Public Land to the Federal government was approved unanimously after discussion and modification.

Senate Minority Leader Dr. Robin Titus addressed the body. Her message centered on winning key seats in the NV Senate and Assembly to preserve Governor Lombardo's vetoes. She focused on electability in certain races.

Following Dr. Titus, we heard from the Chair of the Nevada Commission for Women, Tina Brown, and Destiny McDonial. The message from Tina and Destiny was to get involved in government by pursuing a position on one of the many government boards in a way that ensures conservative voices on government policies.

At the Regents Reception, candidates or their representatives were given an opportunity to speak. The Regents and NvFRW appreciated their support. They were informed that we could only endorse candidates after the Primary.
